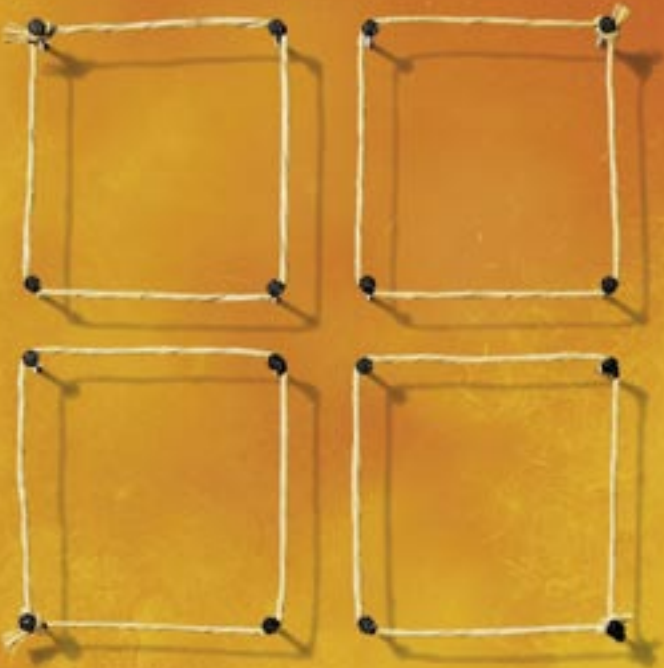

# Release of Benefits

## **Release of superannuation benefits before age 55 is allowed in very limited circumstances.**

This brochure outlines the specific conditions in which superannuation benefits can be released early.

**Superannuation funds have their own rules on early release of superannuation benefits. Before lodging an application, please check if your superannuation fund allows the early release of benefits.**

## **Information contacts at a glance for the early release of superannuation benefits**

In all circumstances, please contact your superannuation fund trustee to determine whether or not your fund allows for the early release of benefits.

### **Specified compassionate grounds**

### **Severe financial hardship, permanent incapacity or preserved benefits balance of \$200 or less**

Please contact your superannuation fund trustee or RSA.

### **Severe financial hardship plus Superannuation Holding Accounts Reserve (SHAR) funds or permanent departure from Australia**

## How can APRA help?

APRA administers the Government legislation that permits the early release of superannuation under 'specified compassionate grounds'. These grounds are set out in the *Superannuation Industry (Supervision) Act 1993*, regulation 6.19A.

Although APRA must be satisfied that your application meets the criteria for early release of superannuation under specified compassionate grounds, the final decision lies with the trustee of your superannuation fund.

As a first step, please contact your superannuation fund to make sure it will allow the early release of your superannuation benefits. Regardless of APRA's approval you will not be able to access your benefits if your fund does not allow the early release of superannuation.

## What are 'specified compassionate grounds'?

APRA can only approve an early release of superannuation benefits on 'specified compassionate grounds'. These grounds are as follows:

### Medical treatment

To help pay for medical costs required to treat a life-threatening illness or injury, to alleviate acute or chronic pain, or to alleviate an acute or chronic mental disturbance – refers to you or your dependant/s.

APRA must be satisfied that the relevant treatment is not readily available through the public health system.

### Medical transport

To assist with the cost of transportation to and from medical treatment by land, water or air to treat a life-threatening illness or injury, to alleviate acute or chronic pain, or to alleviate an acute or chronic mental disturbance – refers to you or your dependant/s.

### Modifications to your home and/or motor vehicle

To fund specific modifications that are necessary to accommodate special needs arising from a severe disability and which are certified by your doctor – refers to you or your dependant/s.

## Funeral assistance

To assist with funeral and other expenses related to the death of a family member – refers only to your dependant/s.

## Palliative care

To provide care for a person who is dying from a terminal illness, including home care – refers to you or your dependant/s.

## Mortgage assistance

To prevent your mortgagee (lender) from selling your principal place of residence – refers only to you.

APRA may also consider the early release of superannuation benefits in cases where the circumstances are 'consistent with' the criteria listed under 'specified compassionate grounds'.

## Making an application on specified compassionate grounds

Please complete an APRA application form only if your circumstances meet those outlined for the early release of superannuation benefits on 'specified compassionate grounds'.

The form includes a checklist of the information needed to support your application. Please ensure you include all supporting documentation; otherwise APRA will reject your application.

**APRA only administers applications for the early release of superannuation on 'specified compassionate grounds'.**

## Other ways to access your superannuation early

Superannuation funds administer the early release of superannuation benefits on the grounds of:

- permanent incapacity;
- permanent departure from Australia;
- preserved benefits balance of \$200 or less;
- severe financial hardship.

Please contact your superannuation fund to discuss your eligibility under any of these grounds.

Alternatively, if you have money in the Superannuation Holding Accounts Reserve (SHAR), which is managed by the Australian Taxation Office (ATO), and you meet the conditions of 'severe financial hardship', please contact the ATO directly to request the early release of your superannuation benefits.
