



Private Health Insurance Frequently Asked Questions

1. What do I have to do from 30 June 2016 to submit returns?

The 30 June Quarterly return are due by 28 July 2016 and must be submitted via D2A. Similarly the 30 June annual return is due by 30 September 2016 and must also be submitted via D2A.

You will need to ensure that you have installed D2A, have an AUSKey that is linked to the ABN of the entity that you are submitting for and you must have completed and sent to APRA the AUSKey acknowledgement form.

2. What is D2A and where can I get further information about D2A?

D2A (Direct to APRA) is a tool through which reporting entities submit data to APRA in Returns and Forms, as per their reporting requirements.

3. Can I submit returns to APRA via D2A without an AUSKey?

No, you cannot submit returns to APRA via D2A without an AUSKey. You must also have completed and sent to APRA the AUSKey acknowledgement form.

5. Why is APRA making this change now?

To achieve benefits from the integration of PHIAC and APRA, APRA has migrated the data collection to D2A. This will best serve the users of the data and best position APRA to continue to satisfy data users' requirements.

6. Can I use the existing PHIAC template to submit return to APRA?

No, you cannot use the existing PHIAC template to submit returns to APRA. You will be required to use the forms within D2A to submit the returns to APRA. However, the information required to submit is exactly the same as the information that you have been submitting to PHIAC.



You can complete the forms in D2A via importing the data using XBRL 2.1, copy paste or manual entry.

7. Can I submit returns using XML?

XML is no longer supported by APRA. APRA will be replacing D2A in the coming 2-3 years and the replacement will be XBRL 2.1 /SBR compliant. To 'future proof' your reporting solution you should use XBRL 2.1 to produce /import your APRA reporting.

10. The PET version of the forms does not provide attribute codes for all the age group items. How do I map all the items in the table to the D2A attribute codes?

Forms in D2A may have data collected either via a grid layout or via a table.

Grid These items are laid out in a grid format i.e. in rows and columns. These items have both row labels and column headings. For a group of items in a grid format each data entry field has a unique attribute code and there are a fixed number of facts that can be reported i.e. one value may be reported for each attribute code.

Table These items are laid out in a table and have column headings but no row labels. All rows within a column have the same attribute code. An entity may report one row, two rows or 1000 or more rows of data. Therefore for each attribute code there may be multiple values reported. Tables may contain drop down boxes.

Where tables contain drop down boxes, they are represented in PET with the allowable entries in the drop down list shown as a list below the relevant D2A cell.
