Colleagues,

On Sunday 26 May the Prime Minister, the Hon Scott Morrison MP announced his [new ministry](#). The Treasury portfolio will have five Ministers after they are sworn in by the Governor-General tomorrow.

The Hon Josh Frydenberg MP will continue as Treasurer and has already reconnected with the department and met with a number of portfolio agencies.

The Hon Michael Sukkar MP is returning to the portfolio as the new Assistant Treasurer and Minister for Housing. He will also have responsibilities in and be cross-sworn into the Social Services portfolio.

The Governor-General will also appoint Senator Jane Hume as the Assistant Minister for Superannuation, Financial Services and Financial Technology.

We will also have a new Cabinet Minister with the Hon Alan Tudge MP taking on the role of Minister for Population, Cities and Urban Infrastructure. With respect to his population responsibilities, he will be cross-sworn to the Treasury portfolio.

Senator the Hon Zed Seselja is to be appointed as Assistant Minister for Finance, Charities and Electoral Matters, maintaining responsibility for charities so will be cross-sworn into the Treasury portfolio.

The Hon Stuart Robert MP will leave the portfolio and join Cabinet as the Minister for the National Disability and Insurance Scheme and Minister for Government Services. I thank the Assistant Treasurer for his service in the portfolio and wish him the best in his future role.

Matt Flavel will be discussing the transfer of population and housing policy to Treasury with his COO colleagues in the Department of Infrastructure, Cities, Regional Development and Water and the Department of Social Services.

Further details on the division of ministerial responsibilities for our portfolio will be provided as they become available.

Treasury has an important job to play in advising the Treasurer and supporting our new portfolio ministers as they settle and I am sure you will all continue to demonstrate your professionalism and expertise.

Departmental Liaison Officers

Departmental Liaison Officers (DLOs) are a vital cog in a smooth running ministerial office.

The Treasury DLOs are also highly-valuable resources for the department and I encourage you to use them to their full capacity.
