TRUSTEES AND RESPONSIBLE OFFICERS

Decision requested on the morning of the 16th JANUARY 2004

Purpose

To recommend that you:

- 1. Disqualify under subsection 120A(1) of the SIS Act each individual trustee listed beside each fund in the attached Schedule.
- 2. Disqualify under subsection 120A(2) of the SIS Act each responsible officer of each corporate trustee listed beside each fund in the attached Schedule.
- 3. Advise each corporate trustee listed in the Schedule that it will be treated as a disqualified person under subsection 120(2) of the SIS Act if it fails to notify APRA by 23 January 2004 that it has removed each disqualified person as a responsible officer of the corporate trustee.
- 4. Approve each trustee of each fund being advised at this point of your intention to remove them as trustees of the funds listed in the Schedule. This is to afford them an opportunity to present a case to the Minister as to why her consent should not be given to their removal.
- 5. Authorise the application of your electronic signature on instruments and letters, as evidence of your decisions in points 1 to 4 above. Templates of these instruments and letters are attached.

Background

- 6. APRA has attempted to contact these funds over the last year to no avail. Letters have been written and phone calls made concerning non lodgement of annual returns, utilising contact details provided by the trustee. Contact has also been attempted indirectly through newspaper advertisements and press releases on the 9th December, advising of these proposed disqualifications, the proposed subsequent removal of trustees and the later formulation of a dissolution instrument. APRA also published details of un-contactable funds on the APRA website.
- 7. Refer to show cause letters issued 9th December 2003 regarding these possible disqualifications.
- 8. The individual trustees and responsible officers have failed to contact APRA to show cause why they should not be disqualified.
