Hi Section 22,

I checked my Outlook messages and previous SHOP tickets lodged to Corporate Affairs, and could find no sign that that Treasury asked us to publish the Jan-Jun 2024 and Jul-Dec 2024 file lists. The last time we published a file list on the APRA website was March 2024 (see attached), and that was for the Jul-Dec 2023 file list. I suspect that Treasury has twice failed to confirm that the 2024 lists were good to publish. This would explain why it slipped our notice.

Could you please have a look at your Outlook correspondence and confirm? If you can't find any confirmation from Treasury (as I suspect) I recommend we ask them why we haven't got our lists approved. In future I recommend putting monthly notices in our calendars, to remind us to get in touch with Treasury if we still haven't got approval for our lists.

Please let me know if you need any further details. Thank you.
