



## Reporting Standard ARS 701.0

### ABS/RBA Definitions for the EFS Collection

#### Objective of this Reporting Standard

This Reporting Standard defines key terms referred to in other reporting standards applicable to authorised deposit-taking institutions (ADIs) and registered financial corporations (RFCs), where these reporting standards form part of the Economics and Financial Statistics (EFS) Collection. All EFS reporting standards applicable to ADIs and RFCs must be read in conjunction with this Reporting Standard.

#### Authority

1. This Reporting Standard is made under section 13 of the *Financial Sector (Collection of Data) Act 2001*.

#### Application and commencement

2. This Reporting Standard applies in relation to the Economics and Financial Statistics (EFS) collection to all entities which submit data to *APRA* under the *EFS reporting standards*.
3. Unless the contrary intention appears, definitions in this Reporting Standard apply to all *EFS reporting standards*.
4. This Reporting Standard commences on 1 January 2019~~applies from the date of commencement of any *EFS reporting standard*.~~

### **Domestic Books**

9.10. The ‘domestic books’ consolidation is defined as follows:

<b>Domestic books</b>	<p>For an <b>ADI</b>:</p> <p>Means an unconsolidated report of positions, transactions and other information recorded on the Australian books of the body corporate authorised by <b>APRA</b> to carry on banking business as per the <i>Banking Act 1959</i>. Includes transactions and positions with both <b>residents</b> and <b>non-residents</b> that are recorded on the Australian books of these entities.</p> <p>Do not consolidate positions, transactions and other information recorded on the books of Extended Licensed Entities (ELEs), of any other entity not consolidated at Level 1 (for example, <b>related parties</b> such as subsidiaries, <b>SPVs</b> or <b>parent entities</b>) and of overseas-based entities (e.g. overseas-based branches and offshore banking units (within the meaning of section 128AE of the <i>Income Tax Assessment Act 1936</i>)).</p> <p>For an <b>RFC</b>:</p> <p>Means an unconsolidated report of positions, transactions and other information recorded on the Australian books of the registered entity as per the <i>Financial Sector (Collection of Data) Act 2001</i>. Includes transactions and positions with both <b>residents</b> and <b>non-residents</b> that are recorded on the Australian books of these entities.</p>

	<p>In general, do not consolidate positions, transactions and other information recorded on the books of <b>related parties</b> (such as subsidiaries, <b>SPVs</b> or <b>parent entities</b>) and of overseas-based entities (e.g. overseas-based branches and offshore banking units (within the meaning of section 128AE of the <i>Income Tax Assessment Act 1936</i>)).</p> <p>However, where an <b>RFC</b> elects to report on behalf of a group of <b>RFCs</b>, these entities are to be consolidated for reporting purposes.</p>

## Residency

<b>Institutional unit</b>	<p>Means an economic entity that is capable of owning assets, incurring liabilities and engaging in economic activities and in transactions with other entities.</p> <p>There are two main types of <b>institutional units</b>:</p> <ul style="list-style-type: none"> <li>• individuals or groups of individuals that form <b>households</b>; and</li> <li>• legal entities such as businesses, non-profit institutions or government units.</li> </ul>
<b>Resident</b> (individual, enterprise or other organisation)	<p>Means any <b>institutional unit</b> whose centre of predominant economic interest (<b>principal place of residence</b> or principal place of production) is within Australia's economic territory.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• <b>households</b> whose <b>principal place of residence</b> is in Australia; and</li> <li>• Australian branches and Australian subsidiaries of foreign enterprises.</li> </ul> <p>It excludes: foreign branches and foreign subsidiaries of Australian enterprises.</p>
<b>Non-resident</b> (individual, enterprise or other organisation)	<p>Means any <b>institutional unit</b> whose centre of predominant economic interest (<b>principal place of residence</b> or principal place of production) is outside Australia's economic territory.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• <b>households</b> whose <b>principal place of residence</b> is overseas; and</li> <li>• foreign branches and foreign subsidiaries of Australian enterprises.</li> </ul> <p>It excludes: Australian-based branches and subsidiaries of foreign enterprises.</p>
<b>Resident</b> (financial instrument)	<p>Means financial instruments (debt, equity or hybrids) that are issued by <b>resident institutional units</b>. Neither the place nor the currency of issuance are to be used to determine residency of a financial instrument unless directed otherwise.</p> <p><b>Derivative</b> contracts are considered <b>resident</b> financial instruments if the counterparty is a <b>resident institutional unit</b>.</p>
<b>Non-resident</b>	<p>Means financial instruments (debt, equity or hybrids) that are issued by <b>non-resident institutional units</b>. Neither the place nor the currency of issuance</p>

(financial instrument)	are to be used to determine residency of a financial instrument unless directed otherwise.  <i>Derivative</i> contracts are considered <i>non-resident</i> financial instruments if the counterparty is a <i>non-resident institutional unit</i> .

<del><i>Authorised deposit-taking institutions (ADIs)</i></del> <u>All other ADIs</u>	<del>Means an <i>ADI</i> that is not a <i>Building Society</i> or a <i>Credit Union</i></del> <u>Means an <i>authorised deposit-taking institution</i> within the meaning of the <i>Banking Act 1959</i>.</u>  <del>Includes <i>banks</i> and <i>non-bank ADIs</i>.</del>
<del><i>Banks</i></del> <u><i>Authorised deposit-taking institutions (ADIs)</i></u>	<del>Means an</del> <u>Are authorised by APRA to use ‘Bank’ or ‘Banker’ in relation to their company name and trading or business name. They are <i>authorised deposit-taking institution</i> within the meaning</u> <del><i>institutions (ADIs)</i> that are authorised under the <i>Banking Act 1959</i>.</del>  <del>A list of <i>banks</i> that are <i>residents</i> can be found on the <i>APRA</i> website at <a href="http://www.apra.gov.au">http://www.apra.gov.au</a>.</del>  <del>It includes: branches and subsidiaries of foreign <i>banks</i> authorised to carry on banking business in Australia under the <i>Banking Act 1959</i>.</del>  It excludes: <ul style="list-style-type: none"><li>• <del>the <i>RBA</i>. Report these under <i>RBA</i>;</del></li><li>• <del><i>credit unions</i> and <i>building societies</i>. Report these under <i>non-bank ADIs</i>; and</del></li><li>• <del>money market corporations. <u><i>Building society</i></u>	<u>Means a locally incorporated <i>ADI</i> that assumes or uses the expression ‘building society’ in relation to its banking business.</u>
<i>Central borrowing authorities</i>	Means entities that primarily provide finance for public corporations and notional institutional units and other units owned or controlled by the government. They arrange the investment of surplus funds.  <i>Central borrowing authorities</i> raise funds predominantly by issuing securities. They also engage in other intermediation activity for investment purposes, and may participate in the financial management activities of the parent government.  It includes all <i>central borrowing authorities</i> established by state and territory governments.
<i>Clearing houses and central counterparties</i>	Means all recognised clearing houses, such as the Australian Stock Exchange Clearing House and Sydney Futures Exchange Clearing House.  Central counterparties (CCPs) are clearing houses that interpose themselves between counterparties to contracts traded in one or more financial markets,

	<p>becoming the buyer to every seller and the seller to every buyer. A CCP becomes counterparty to trades with market participants through novation, an open offer system, or another legally binding arrangement.</p> <p><i>Central counterparties and clearing houses are financial auxiliaries.</i></p>
<p><b>Commonwealth general government</b></p>	<p>Means Australian Commonwealth Government departments and agencies whose principal function is to provide non-market goods and services, principally financed by taxes, for free or at a price well below the cost of production. These entities regulate economic activity, maintain law and order and redistribute income and wealth by means of transfers.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• departments and agencies such as Department of Finance, Department of Defence, Australian Broadcasting Corporation, Special Broadcasting Service, Australian Film Commission and CSIRO;</li> <li>• Commonwealth Government unincorporated enterprises that provide goods and services to the Australian Commonwealth Government and/or to the public for free or at prices that are not economically significant (e.g. government employee cafeterias, munitions factories);</li> <li>• non-profit institutions (NPIs) controlled and mainly financed (other than by grants) by the Commonwealth Government;</li> <li>• Commonwealth Government quasi-corporations that sell their output, at near <i>market prices</i>, exclusively to other government units (e.g. government printers and defence force housing schemes); and</li> <li>• public universities.</li> </ul> <p>It excludes:</p> <ul style="list-style-type: none"> <li>• government trading enterprises such as Australia Post. Report these under <i>Commonwealth Government non-financial corporations, state, territory and local government non-financial corporations</i> or <i>financial institutions</i> as appropriate; and</li> <li>• departments of the state and territory governments. Report these as <i>state, territory and local general government</i>;</li> <li>• the <i>RBA</i> and Commonwealth Government <i>financial institutions</i> such as Australian Industry Development Corporation and Export Finance and Insurance Corporation. Report these under <i>financial institutions</i> as appropriate; and</li> <li>• NPIs credited for philanthropic purposes that are financed mainly from donations or government grants. <p><b>Commonwealth Government non-financial corporations</b></p>	<p>Means those businesses that are owned and controlled by the Australian Commonwealth Government and that produce goods or non-financial services for sale at <i>market prices</i>.</p> <p>It includes: all <i>resident</i> trading enterprises owned 50% or more by the Commonwealth Government or controlled by the Commonwealth Government through legislation, decree or regulation (e.g. Australia Post, Australian Government Solicitor, Snowy Hydro Ltd, NBN Co Limited and Air Services Australia).</p>

	<p>It excludes:</p> <ul style="list-style-type: none"> <li>• government departments. Report these as <b>general government</b>; and</li> <li>• government-owned <b>financial institutions</b>. Report these under <b>financial institutions</b>.</li> </ul>
<b>Community service organisations</b>	<p>Means non-market operators providing goods and services to <b>households</b> for free or at prices that are not economically significant. Included here are <del>non</del>not-for-profit institutions (NPIs) that are mainly financed from <b>household</b> member subscriptions and produce benefits primarily for the <b>household</b> members and NPIs credited for philanthropic purposes that are financed mainly from donations or government grants.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• aid agencies, charities, consumers associations, cultural clubs, learned societies, political parties, recreational clubs, relief agencies, religious institutions, social clubs, sports clubs, trade unions; and</li> <li>• NPIs credited for philanthropic purposes that are financed mainly from donations or government grants.</li> </ul> <p>It excludes:</p> <ul style="list-style-type: none"> <li>• <b>community service organisations</b> and <del>NPIs</del>not-for-profit institutions controlled and mainly financed (other than by grants) by government. Report these under <b>general government</b>.</li> <li>• NPIs that are engaged in market production. Report these in <b>non-financial businesses</b> or <b>financial institutions</b> as appropriate.</li> </ul>
<u>Credit union</u>	<u>Means a locally incorporated ADI that assumes or uses the expression ‘credit union’ in relation to its banking business and includes Cairns Penny Savings &amp; Loans Limited.</u>
<b>Exchange-traded funds (ETFs)</b>	<p>Means investment vehicles that are listed on a stock exchange and provide investors with the return of some benchmark, such as an equity index.</p> <p><b>ETFs</b> are a type of <b>non-money-market financial investment fund</b>.</p>
<b>Financial auxiliaries</b>	<p>Means corporations and quasi-corporations engaged primarily in activities closely related to financial intermediation, but which do not themselves perform an intermediation role.</p> <p>It includes: fund managers as principal, stockbrokers, insurance brokers, investment advisors and corporations providing infrastructure for financial markets.</p>
<b>Financial institutions</b>	<p>Means all corporations and notional institutional units mainly engaged in financial intermediation and the provision of auxiliary financial services. Holding companies with mainly financial corporations as their subsidiaries are also included, as are market <del>non</del>not-for-profit institutions (NPIs) that mainly engage in financial intermediation or the production of auxiliary financial services.</p> <p><b>Financial institutions</b> include (but are not limited to): the <b>RBA</b>, <del>banks, non-bank</del>ADIs, <b>registered financial corporations</b>, <b>central borrowing authorities</b>, <b>life insurance corporations</b>, <b>other insurance corporations</b>, <b>self-managed superannuation funds</b>, <b>other superannuation funds</b>, <b>financial auxiliaries</b>,</p>



	<i>securitisers, money-market investment funds and non-money-market financial investment funds.</i>
<b>Financial institutions n.e.c.</b>	<p>Means any <i>financial institutions</i> other than the <i>RBA, <del>banks, non-bank ADIs, registered financial corporations, central borrowing authorities, life insurance corporations, other insurance corporations, self-managed superannuation funds, other superannuation funds, financial auxiliaries, securitisers, money-market investment funds and non-money-market financial investment funds.</del></i></p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• warehouses;</li> <li>• structured investment vehicles (SIVs); and</li> <li>• non-traditional lenders.</li> </ul>
<b>General government</b>	Means <i>Commonwealth general government and state, territory and local general government.</i>
<b>Households</b>	<p>Means persons whose dealings with other sectors are for <i>personal</i> or <i>housing</i> purposes.</p> <p>It excludes:</p> <ul style="list-style-type: none"> <li>• persons whose dealings with other sectors are for <i>business</i> purposes. Report these under <i>non-financial businesses</i> or <i>financial institutions</i>;</li> <li>• sole proprietors, partnerships, and any other unincorporated enterprises owned by <i>households</i>. Report these under <i>private unincorporated businesses</i> or the relevant sector in <i>financial institutions</i>;</li> <li>• companies owned by <i>households</i>. Report these under <i>private non-financial corporations</i>;</li> <li>• family trusts. Report these under <i>private unincorporated businesses</i> or <i>financial institutions</i> as appropriate;</li> <li>• <i>self-managed superannuation funds</i>. Report these as <i>self-managed superannuation funds</i>; and</li> <li>• incorporated businesses. Report these under <i>non-financial businesses</i> (other than <i>unincorporated businesses</i>) or <i>financial institutions</i>.</li> </ul>
<b>Insurance corporations</b>	Means <i>life insurance corporations</i> and <i>other insurance corporations</i> .
<b>Life insurance corporations</b>	<p>Means life insurance companies and friendly societies that are registered under the <i>Life Insurance Act 1995</i> and are regulated by <i>APRA</i>. They offer insurance for death or disability and also offer investment and superannuation products.</p> <p><del>A list of <i>life insurance corporations</i> (both <i>life insurance companies</i> and <i>friendly societies</i>) can be found on the <i>APRA</i> website at <a href="http://www.apra.gov.au">http://www.apra.gov.au</a>.</del></p> <p>It includes: life insurance companies, life reinsurance companies and friendly societies.</p> <p>It excludes:</p> <ul style="list-style-type: none"> <li>• insurance companies offering house, car and marine insurance. Report these under <i>other insurance corporations</i>; and</li> </ul>



	<ul style="list-style-type: none"> <li>health benefit funds that are regulated under the <i>Private Health Insurance (Prudential Supervision) Act 2015</i>. Report these under <b>other insurance corporations</b>.</li> </ul>
<b>Money-market investment funds</b>	<p>Means collective investment schemes, such as cash management trusts and cash common funds, that are constituted as legal entities. They raise funds by issuing shares or units to the public, either via a prospectus or a distribution channel such as a platform.</p> <p>The proceeds are invested primarily in money-market instruments, money-market shares/units, and transferable debt instruments with a <b>residual maturity</b> of less than or equal to 12 months, <b>deposits</b> at <b>banks</b>, and instruments that pursue a rate of return that approaches the interest rates of money-market instruments.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>cash common funds;</li> <li>money-market funds; and</li> <li>cash management trusts.</li> </ul>
<del><b>Non-bank ADIs</b></del>	<p><del>Means a body corporate authorised under subsection 9(3) of the <i>Banking Act 1959</i> to carry on banking business in Australia, but which does not hold a consent under section 66 of the <i>Banking Act 1959</i> to use the word ‘bank’.</del></p> <p><del>A list of <b>ADIs</b> (including both <b>banks</b> and <b>non-bank ADIs</b>) that are <b>residents</b> can be found on the <b>APRA</b> website at <a href="http://www.apra.gov.au">http://www.apra.gov.au</a>.</del></p> <p><del>It includes: building societies, credit unions, other ADIs (including providers of purchased payment facilities) and authorised non-operating holding companies.</del></p> <p><del>It excludes:</del></p> <ul style="list-style-type: none"> <li><del><b>banks</b>. Report these under <b>banks</b>; and</del></li> <li><del>the <b>RBA</b>. Report this under <b>RBA</b>.</del></li> </ul>
<b>Non-financial businesses</b>	<p>Means <b>private non-financial investment funds, other private non-financial corporations, private unincorporated businesses, Commonwealth Government non-financial corporations</b> and <b>state, territory and local government non-financial corporations</b>.</p>
<b>Non-money-market financial investment funds</b>	<p>Means collective investment schemes, such as trusts or corporations, that are constituted as legal entities. They raise funds by issuing shares or units to the public, either via a prospectus or a distribution channel such as a platform.</p> <p>The proceeds are used to purchase financial assets. The assets are owned by the investment fund and usually managed by licensed fund managers external to the fund. Investors are able to dispose of their units/shares on a well-developed secondary market such as a stock exchange or through readily accessible redemption facilities.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>funds with predominantly overseas property or infrastructure holdings;</li> <li>listed and unlisted equity trusts (domestic and international);</li> </ul>

	<ul style="list-style-type: none"> <li>• listed and unlisted mortgage trusts;</li> <li>• listed investment companies; and</li> <li>• non-cash common funds.</li> </ul> <p>It excludes: investment funds that predominately invest in non-financial assets. Report these in <i>private non-financial investment funds</i>.</p>
<b>Non-resident banks</b>	<p>Means any <i>non-resident financial institution</i> whose business is to receive <i>deposits</i> (or close substitutes for <i>deposits</i>) and to extend credit or invest in securities on their own account.</p> <p><del>It excludes: <i>resident banks</i>.</del></p>
<b>Non-resident superannuation funds</b>	<p>Means any <i>non-resident</i> funds designed specifically for the purpose of providing a pension or other income stream on retirement.</p> <p>It excludes:</p> <ul style="list-style-type: none"> <li>• <i>other superannuation funds</i> that are <i>residents</i>; and</li> <li>• <i>self-managed superannuation funds</i> that are <i>residents</i>.</li> </ul>
<b><u>Non-profit institutions (NPIs)</u></b>	<p><u>Means any legal entity which:</u></p> <ul style="list-style-type: none"> <li>• <u>is created for the purpose of producing goods and services, and;</u></li> <li>• <u>whose articles of association prohibit it from being a source of income, profit or other financial gain to the units that establish, control or finance the legal entity.</u></li> </ul>
<b>Other insurance corporations</b>	<p>Means all insurance corporations registered as a general insurance company or private health insurance company with <i>APRA</i> under <i>the Insurance Act 1973</i> (or by virtue of determinations made by <i>APRA</i> under the <i>General Insurance Reform Act 2001</i>) or the <i>Private Health Insurance (Prudential Supervision) ACT 2015</i>, respectively. This includes general, fire, accident, employer liability, household and consumer credit insurers and health insurance funds. They mainly offer house, car and marine insurance.</p> <p>It includes the following even though these are not registered with <i>APRA</i>:</p> <ul style="list-style-type: none"> <li>• Export Finance Insurance Corporation; and</li> <li>• private sector and government-owned general and health insurance enterprises, both proprietary and mutual.</li> </ul> <p>It excludes:</p> <ul style="list-style-type: none"> <li>• life insurance companies, life reinsurance companies and friendly societies. Report these under <i>life insurance companies</i>; and</li> <li>• insurance brokers. Report these under <i>financial auxiliaries</i>.</li> </ul>
<b>Other private non-financial corporations</b>	<p>Means corporations that are owned and controlled by the <del>private</del> (non-government) sector, whose main activity is producing goods or non-financial services for sale at market prices. <b><i>Accommodation and food services</i></b>	Means businesses mainly engaged in providing short-term accommodation for visitors. Also included are businesses mainly engaged in providing food and beverage services, such as the preparation and serving of meals and the serving of alcoholic beverages for consumption by customers, both on- and off-site.
<b><i>Administrative and support services</i></b>	<p>Means businesses engaged in performing routine support activities for the day-to-day operations of other businesses or organisations.</p> <p>Businesses providing administrative support services are mainly engaged in activities such as office administration; hiring and placing personnel for others; preparing documents; taking orders for clients by telephone; providing credit reporting or collecting services; and arranging travel and travel tours.</p> <p>Businesses providing other types of support services are mainly engaged in activities such as buildings and other cleaning services; pest control services; gardening services; and packaging products for others.</p> <p>The activities undertaken by businesses in this industry are often integral parts of the activities of businesses found in all sectors of the economy. Recent trends have moved more towards the outsourcing of such non-core activities. The businesses classified in this industry specialise in one or more of these activities and can, therefore, provide services to a variety of clients.</p>
<b><i>Agriculture, forestry and fishing</i></b>	Means businesses mainly engaged in growing crops, raising animals, growing and harvesting timber, and harvesting fish and other animals from farms or their natural habitats.
<b><i>Arts and recreation services</i></b>	Means businesses mainly engaged in the preservation and exhibition of objects and sites of historical, cultural or educational interest; the production of original artistic works and/or participation in live performances, events, or exhibits intended for public viewing; and the operation of facilities or the provision of services that enable patrons to participate in sporting or recreational activities, or to pursue amusement interests.
<b><i>Construction (industry)</i></b>	Means businesses mainly engaged in construction, additions, alterations, reconstruction, installation, and maintenance and repairs of buildings and other structures. Businesses engaged in demolition or wrecking of buildings and other structures, and clearing of building sites are included. It also includes

	<p>businesses engaged in blasting, test drilling, landfilling, levelling, earthmoving, excavation, land drainage and other land preparation.</p> <p><b>Construction</b> includes:</p> <ul style="list-style-type: none"> <li>• <b>residential building construction;</b></li> <li>• <b>non-residential building construction;</b> and</li> <li>• <b>other construction.</b></li> </ul>
<b>Education and training</b>	<p>Means businesses mainly engaged in the provision and support of education and training, except those engaged in the training of animals e.g. dog obedience training, horse training (report these in <b>other services</b>).</p> <p>Education may be provided in a range of settings, such as educational institutions, the workplace, or the home. <b>Electricity, gas, water and waste services</b>	<p>Means businesses engaged in the production of electricity; gas through mains systems; water; drainage; and sewage services. <b>Financial and insurance services</b>	<p>Means businesses mainly engaged in financial transactions involving the creation, liquidation or change in ownership of assets, and/or in facilitating financial transactions.</p> <p>The range of activities includes raising funds by taking <b>deposits</b> and/or issuing securities and, in the process, incurring liabilities; businesses investing their own funds in a range of financial assets; pooling risk by underwriting insurance and annuities; separately constituted funds engaged in the provision of retirement incomes and specialised services facilitating or supporting financial intermediation, insurance and employee benefit programs. Also included are central banking, monetary control and the regulation of financial activities.</p>
<b>Health care and social assistance</b>	<p>Means businesses mainly engaged in providing human health care and social assistance. Businesses engaged in providing these services apply common processes, where the labour inputs of practitioners with the requisite expertise and qualifications are integral to production or service delivery.</p>
<b>Information media and telecommunications</b>	<p>Means businesses mainly engaged in:</p> <ul style="list-style-type: none"> <li>• creating, enhancing and storing information products in media that allows for their dissemination;</li> <li>• transmitting information products using analogue and digital services (via electronic, wireless, optical or other means); and</li> <li>• providing transmission services and/or operating the infrastructure to enable transmission and storage of information and information products.</li> </ul>
<b>Manufacturing</b>	<p>Means businesses mainly engaged in the physical or chemical transformation of materials, substances or components into new products (except agriculture and <b>construction</b>). The materials, substances or components transformed by</p>

	<p>businesses in this industry are raw materials that are products of <b>agriculture, forestry and fishing, mining</b> or products of other <b>manufacturing</b> businesses.</p> <p>Activities undertaken by businesses incidental to their <b>manufacturing</b> activity, such as selling directly to the consumer products manufactured on the same premises from which they are sold, such as bakeries and custom tailors, are also included in this industry. If, in addition to self-produced products, other products that are not manufactured by the same business are also sold, the rules for the treatment of mixed activities have to be applied and businesses classified according to their predominant activity.</p> <p>Assembly of the component parts of manufactured products, either self-produced or purchased from other businesses, is considered <b>manufacturing</b>. The term mining is used in the broad sense to include underground or open cut mining; dredging; quarrying; well operations or evaporation pans; recovery from ore dumps or tailings as well as beneficiation activities (i.e. preparing, including crushing, screening, washing and flotation) and other preparation work customarily performed at the mine site or as part of the mining activity.</p>
<b>Non-residential building construction</b>	<p>This class consists of units mainly engaged in the construction of <b>non-residential buildings</b> such as hotels, motels, hostels, hospitals, prisons or other buildings, in carrying out alterations, additions or renovation to such buildings, or in organising or managing these activities.</p>
<b>Other construction</b>	<p>This class consists of units mainly involved in heavy and civil engineering construction, or other construction services including: land development and site preparation; building structure services; building installation services; building completion services; and other construction services (such as landscaping or the hire of construction machinery).</p>

Businesses in this industry specialise and sell this expertise and, in most cases, equipment and materials are not major inputs.</p> <p><b><i>Professional, scientific and technical services</i></b> include scientific research, architecture, engineering, computer systems design, law, accountancy, advertising, market research, management and other consultancy, veterinary science and professional photography.</p>
<b><i>Public administration and safety</i></b>	<p>Means businesses mainly engaged in central, state or local government legislative, executive and judicial activities; in providing physical, social, economic and general public safety and security services; and in enforcing regulations. Also included are businesses of military defence, government representation and international government organisations.</p>
<b><i>Rental, hiring and real estate services</i></b>	<p>Means businesses mainly engaged in renting, hiring or otherwise allowing the use of assets (except copyrights), and businesses providing related services. The assets may be tangible, as in the case of real estate and equipment, or intangible, as in the case with patents and trademarks.</p> <p>The industry also includes businesses engaged in providing real estate services such as selling, renting and/or buying real estate for others, managing real estate for others and appraising real estate.</p>

These activities include stevedoring services, harbor services, navigation services, airport operations and customs agency services.
<b><i>Wholesale trade</i></b>	Means businesses mainly engaged in the purchase and on-selling, the commission-based buying, and the commission-based selling of goods, without significant transformation, to businesses.  Businesses are classified to the <b><i>wholesale trade</i></b> industry in the first instance if they buy goods and then on-sell them (including on a commission basis) to businesses.  Wholesalers' premises are usually a warehouse or office with little or no display of their goods, large storage facilities, and are not generally located or designed to attract a high proportion of walk-in customers. Wholesaling is often characterised by high value and/or bulk volume transactions, and customers are generally reached through trade-specific contracts. Also include businesses that sell to both other businesses and the general public ( <b><i>households</i></b> ) that also have these characteristics.

<b>Borrower-accepted commitment (commitment)</b>	<p>Means a firm offer to provide finance that has been accepted by the borrower.</p> <p>A <i>borrower-accepted commitment</i> exists for a <i>loan</i> or <i>finance lease</i> once an <i>application</i> has been <i>approved</i>, a <i>loan/finance lease</i> contract or letter of offer has been issued to the borrower, and the borrower has accepted the offer.</p> <p>For <i>bills</i>, a <i>borrower-accepted commitment</i> occurs when the <i>bill</i> is <i>accepted</i>.</p> <p>It includes: agreements to increase the <i>credit limit</i> of an existing <i>loan</i> contract (for example, as part of an <i>internal refinance</i>).</p>

It is typically a negotiable instrument with an <b>original maturity</b> of 180 days or less.

<b>Break fees charged</b>	Means fees charged by the lender when a customer terminates a contract early. <i>Dividends income</i>	<p>Represents all profits incurred by corporations whether or not the distributions are called dividends.</p> <p>It excludes: issues of bonus shares in lieu of dividends (i.e. exclude dividend reinvestment plans).</p>

<b>Dwelling</b>	<p>Means a self-contained room or suite of rooms, including cooking and bathing facilities, intended for long-term residential use. A <b><i>dwelling</i></b> is private (not generally accessible by the public) and is contained within a building that is an immobile structure. A <b><i>dwelling</i></b> may comprise part of a building or the whole of a building.</p> <p>Regardless of whether they are self-contained or not, rooms within buildings offering institutional care (e.g. hospitals) or where the primary purpose is to provide temporary accommodation (e.g. hotels, motels and hostels) are not defined as <b><i>dwelling</i></b>s.</p>

<b>Exception fees charged</b>	Means pre-determined charges that are imposed in the event of a breach of contract by the customer. It includes fees for: <ul style="list-style-type: none"> <li>• late payment;</li> <li>• insufficient funds in a <b>deposit</b> account; and</li> <li>• overdrawn <b>credit limit</b> where there is no overdraft facility.</li> </ul> It excludes fees for: <ul style="list-style-type: none"> <li>• overdrawn accounts with a pre-arranged overdraft facility; and</li> <li>• <b>break fees charged</b>.</li> </ul>
<b>Excess repayments</b>	Means any repayment amount by which actual repayments exceed <b>scheduled repayments</b> during a specified period.
<b>Exclusive contract</b>	Means an arrangement where the lender or its agent negotiates an exclusive arrangement with a borrowing counterparty. The borrower pays a set upfront fee for exclusive access to borrow from the lender's securities portfolio.
<b>Existing dwelling</b>	Means a <b>dwelling</b> that has been previously occupied.
<b>Exposure size</b>	Means the value of all liabilities that a borrower has owing to the <b>ADI</b> or <b>RFC</b> .
<b>External refinance</b>	Occurs where a new <b>loan</b> is obtained to replace an existing <b>loan</b> that was provided by a different lender (e.g. for <b>ADIs</b> , a lender that is not within the regulated <b>ADI</b> itself). For <b>housing</b> , it includes refinancing an existing <b>loan</b> for the same <b>residential property</b> . It excludes: refinanced <b>housing loans</b> used for a different <b>residential property</b> .
<b>Extraordinary/special dividend</b>	Refers to non-recurring, irregularly scheduled and declared dividends which are separate from the normal dividend cycle of this <b>ADI</b> or <b>RFC</b> . The dividend is disproportionately large relative to the recent level of normal dividends paid.

<b>First-home buyer</b>	<p>Means a borrower entering the home ownership market for the first time, whether or not they are purchasing a <b>dwelling</b> for <b>owner-occupied</b> or <b>investment</b> purposes.</p> <p>This includes all borrowers entering the home ownership market for the first time, regardless of whether or not they have received or are eligible for a first-home buyer grant.</p> <p>If there is more than one party to the loan, a loan is classified as being to a <b>first-home buyer</b> if none of the borrowing parties to the <b>commitment</b> have previously owned a <b>dwelling</b>.</p> <p>It excludes: <b>internal refinance</b> and <b>external refinance</b> of loans that were originally made to <b>first-home buyers</b>.</p>

<b><i>Foreign-sourced income</i></b>	<p>Means the allowable income, as defined by the <b><i>ADI</i></b>'s or <b><i>RFC</i></b>'s serviceability assessment policy, which is sourced from a country other than Australia. Allowable income is the total of the borrower's main pre-tax income and any other pre-tax income, for example, overtime, rental income and dividends, to the extent that the <b><i>ADI</i></b> or <b><i>RFC</i></b> takes such income into account, in whole or in part, in its serviceability assessments.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• income streams derived from governments overseas or non-governmental entities incorporated overseas; and</li> <li>• FX-denominated income.</li> </ul> <p>It excludes: income streams derived from unincorporated or incorporated entities in Australia that export goods or services.</p>

<b><i>Hardware and software application costs</i></b>	Means hardware and software purchased from third parties (i.e. material costs).
<b><i>Holding gains / losses on assets and liabilities</i></b>	<p>Refers to realised and unrealised gains / losses on assets and liabilities.</p> <p>Realised gains / losses on assets and liabilities refer to changes in the value of assets and liabilities as a result of closing or disposal of assets and liabilities.</p> <p>Unrealised gains / losses on assets and liabilities refer to changes in the value of assets and liabilities as a result of changes in the <b><i>market value</i></b> of those assets and liabilities.</p>
<b><i>Home equity loan</i></b>	Means a <b><i>secured revolving credit</i></b> facility that is <b><i>secured</i></b> by the borrower's equity in <b><i>residential property</i></b> .

<b>Hybrid securities</b>	<p>Means securities that combine elements of <i>debt securities</i> and <i>equity securities</i>.</p> <p>Regulatory capital instruments such as <i>Additional Tier 1</i> and <i>Tier 2 capital instruments</i> are types of <i>hybrid securities</i>.</p> <p>A distinction is made in reporting between <i>hybrid securities treated as liabilities</i> and <i>hybrid securities treated as equity</i> under Australian Accounting Standards.</p>
<b>Hybrid securities treated as liabilities</b>	<p>Means <i>hybrid securities</i> that are treated as liabilities under Australian Accounting Standards. Report these as <i>debt securities</i> and separately identified as directed.</p>

<b>'In use' information technology equipment</b>	<p>Refers to <i>information technology equipment</i> classified as <i>property, plant and equipment</i> (including software applications that are an integral part of hardware) used in the production process of the institution as at the reporting date.</p>
<b>Individual provision</b>	<p>Means all provisions for impairment assessed by an <i>ADI</i> or <i>RFC</i> on an individual basis as defined by the Australian Accounting Standards.</p>
<b>Industrial buildings</b>	<p>Means any <i>non-residential buildings</i> (or parts of such buildings) where the primary purpose is for manual labour or storage.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• warehouses; and</li> <li>• factories.</li> </ul>
<b>Industrial machinery and equipment</b>	<p>Represents machinery and equipment where the primary business function is for use in the production of goods and/or services.</p> <p>Some items within this category may be mobile and capable of transporting people or goods.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• engines and turbines;</li> <li>• pumps, compressors and hydraulic power engines;</li> <li>• lifting and handling equipment;</li> <li>• machine tools and accessories (hand tools, tools customarily in a workshop);</li> <li>• equipment for food and beverage preparation</li> <li>• point of sale terminals and booking systems;</li> </ul>

	<ul style="list-style-type: none"> <li>• industrial cooking appliances;</li> <li>• domestic appliances for production purposes; and</li> <li>• climate control systems and other equipment in core production.</li> </ul>
<b>Information technology equipment</b>	<p>Refers to devices that have a primary function related to the collection, transfer, storage, or processing of data.</p> <p>Examples include, computers, monitors, keyboards, drives and servers.</p>
<b>Information technology expenses incurred</b>	<p>Refers to expenses incurred during the reporting period related to the use of information technology (including equipment, software and services).</p> <p>It excludes:</p> <ul style="list-style-type: none"> <li>• <b>wages and salaries</b> of own employees; and</li> <li>• <b>computer software capitalised</b>.</li> </ul>
<b>Insurance premiums other than workers compensation</b>	<p>It includes:</p> <ul style="list-style-type: none"> <li>• optional third party and comprehensive motor vehicle insurance premiums;</li> <li>• fire, general, accident and public liability premiums; and</li> <li>• professional indemnity insurance premiums.</li> </ul> <p>It excludes:</p> <ul style="list-style-type: none"> <li>• workers compensation insurance premiums/levies. Report this as <b>workers' compensation premiums/costs</b>; and</li> <li>• compulsory third party motor vehicle insurance premiums.</li> </ul>
<b>Intangible assets</b>	Has the meaning as in <i>AASB 138 Intangible Assets</i> (AASB 138).
<b>Interest-bearing</b>	<p>Means liabilities that have a contractual <b>interest rate</b> greater than zero.</p> <p>If an account has more than one contractual <b>interest rate</b>, report as <b>interest-bearing</b> if at least one of the contractual <b>interest rates</b> is greater than zero.</p>
<b>Interest expense incurred</b>	<p>Payments of interest incurred during the period that are due to customers and holders of <b>debt securities</b> during the period, including coupon payments.</p> <p>Report <b>interest expense incurred</b> in accordance with Australian Accounting Standards.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• payments of scheduled interest distributions made during the period;</li> <li>• the interest component of zero coupon security repayments, borrowing under <b>repurchase agreements</b> and <b>securities borrowing</b> activity; and</li> <li>• scheduled interest payments that were not made during the period (including scheduled distributions on hybrid instruments).</li> </ul> <p>It excludes: non-interest payments made to customers or holders of <b>debt securities</b> (such as principal payments or fees).</p>
<b>Interest income earned</b>	Interest earned from customers and issuers of securities during the period, including coupon payments.



	<p>Report <i>interest income earned</i> in accordance with Australian Accounting Standards.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• payments of scheduled interest distributions received during the period;</li> <li>• the interest component of funds received from zero coupon security repayments, <i>repurchase agreements</i> and <i>securities lending</i> activity; and</li> <li>• scheduled interest payments that were not received during the period (including scheduled distributions on <i>hybrid securities</i>).</li> </ul> <p>It excludes: non-interest payments received from customers or issuers of <i>debt securities</i> (such as principal payments or fees).</p>

<b><i>Interest rate</i></b>	<p>Means the contractual rate to be paid to or received by the customer/counterparty/debtholder. <b>Large (business size)</b>	<p>A business is classified as <i>large</i> if they have <i>turnover</i> greater than or equal to \$50 million.</p> <p>Include exposures classified by <i>ADIs</i> using the internal ratings-based approach to credit risk as ‘Corporate’ in this category.</p>
<b>Leases</b>	<p>Has the meaning as in <a href="#">AASB 16447 Leases</a> (AASB <a href="#">16447</a>).</p> <p>In general, means an agreement whereby the lessor conveys to the lessee in return for a payment or series of payments the right to use an asset for an agreed period of time.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• <i>finance leases</i>; and</li> <li>• <i>operating leases</i>.</li> </ul>
<b>Legal expenses</b>	Refers to fees incurred when a business secures the services of a legal representative, or requires legal representation, or seeks professional advice on legal matters.
<b><u>Lending fee/premium</u></b>	<u>Refers to a fee/premium that the borrower of a security pays to the lender when the securities loan is backed by non-cash collateral. The lending fee/premium is predetermined in a securities lending agreement between the borrower and lender and should be expressed as an annualised percentage of the market value of the securities borrowed.</u>
<b>Loan-to-valuation ratio (LVR)</b>	Defined in Attachment D of <i>Prudential Standard APS 112 Capital Adequacy: Standardised Approach to Credit Risk</i> (APS 112).
<b>Loans</b>	<p>Means a financial asset that is: (1) created when a creditor lends funds directly to a debtor; and (2) is evidenced by non-negotiable documents.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• advances;</li> <li>• <i>secured</i> and <i>unsecured loans</i>;</li> </ul>

<b>Margin</b>	<p>Means the <i>weighted average</i> internal margin on that product (the amount added to the <i>cost of funds</i> or subtracted from the <i>value of funds</i> to determine the <i>interest rate</i>).</p> <p>For assets, the <i>margin</i> is equal to the <i>weighted average interest rate</i> charged to the borrower less the <i>cost of funds</i>.</p> <p>For liabilities, the <i>margin</i> is equal to the weighted average <i>interest rate</i> paid to the depositor or holder less the <i>value of funds</i>.</p>
<b>Margin call</b>	<p><b>Margin calls</b> occur when falls in the value of the borrower's <i>security</i> cause the <i>LVR</i> to exceed the borrower's maximum <i>LVR</i> plus the 'buffer'. The 'buffer' is typically about 5 to 10 per cent, and allows borrowers to utilise the maximum allowable <i>LVR</i> on their <i>security</i> without continually receiving <i>margin calls</i> due to usual fluctuations in share prices.</p> <p>In the event of a <i>margin call</i>, the borrower is contacted and is required to reduce the <i>LVR</i> on their <i>loan</i>, usually by contributing additional approved <i>security</i>, paying down the <i>loan</i> by selling part of the existing portfolio, or depositing additional cash.</p>
<b>Margin lending/loans</b>	<p><b>Margin lending</b> facilities are defined in Section 761EA of the <i>Corporations Act 2001</i>.</p> <p><b>Margin lending</b> is the provision of <i>secured loans</i> to investors for the purpose of purchasing financial assets. The purchased assets are generally used as <i>security</i> for the <i>margin loan</i>. They are the amounts of money that willing buyers pay to acquire something from willing sellers; the exchanges are made between independent parties and on the basis of commercial consideration only (i.e. at 'arm's length').</p>

<b>Medium (business size)</b>	A business is classified as <i>medium</i> if the <i>ADI</i> or <i>RFC</i> has a total exposure to the business that is greater than or equal to \$1 million and the business has <i>turnover</i> of less than \$50 million.  Include exposures classified by <i>ADIs</i> using the internal ratings-based approach to credit risk as ‘SME Corporate’ in this category.
<b>Merchant fees charged</b>	Means fees charged to merchants for providing payment processing services.  It includes: <ul style="list-style-type: none"> <li>• <i>per-transaction merchant fees charged</i>; and</li> <li>• <i>non-transaction merchant fees charged</i>.</li> </ul>

## N

<b>Negotiable certificate of deposit</b>	Means negotiable-bearer <i>debt securities</i> . They are issued at a discount to the face value, can be traded in the secondary market and do not require endorsement when sold. Include transferable <i>certificates of deposit</i> .
<b>Newly erected dwelling</b>	Refers to a <i>dwelling</i> that has not previously been occupied by a <i>household</i> .  It includes: <ul style="list-style-type: none"> <li>• off-the-plan purchases; and</li> <li>• <i>dwellings</i> resulting from the conversion of <i>non-residential buildings</i> to <i>dwellings</i>.</li> </ul> It excludes: <i>existing dwellings</i> that have been refurbished or renovated.
<b>Non-building structures</b>	Means any structures that are not buildings.  It includes: roads, bridges, railways, harbours, mines, telecommunication towers, dams, powerlines, pipelines and sewers.
<b>Non-current assets and disposal groups classified as held for sale</b>	Has the meaning in <i>AASB 5 Non-current Assets Held for Sale and Discontinued Operations</i> (AASB 5).
<b>Non-interest-bearing</b>	Means <i>deposits</i> that have a contractual <i>interest rate</i> equal to zero.  If an account has more than one contractual <i>interest rate</i> , report as <i>non-interest-bearing</i> if none of the contractual <i>interest rates</i> are greater than zero.
<b>Non-lending losses and frauds</b>	Refers to <i>non-lending losses and fraud</i> expenses such as litigation costs for the relevant period as determined in accordance with Australian Accounting Standards.
<b>Non-negotiable certificates of deposit</b>	Means <i>certificates of deposit</i> that must be held by the depositor until maturity unless a penalty is paid for early withdrawal of the <i>deposit</i> . They are to be classified as a <i>fixed-term deposit</i> .
<b>Non-residential buildings</b>	Means any buildings (or part of buildings) that are not <i>dwellings</i> .  Generally include: <ul style="list-style-type: none"> <li>• <i>shops</i>;</li> </ul>

	<ul style="list-style-type: none"> <li>• <i>offices</i>;</li> <li>• <i>industrial buildings</i>; and</li> <li>• any other buildings that are not <i>dwelling</i>s.</li> </ul>
<b>Non-residential land</b>	Means any vacant land that does not have a building attached and that is not <i>residential land</i> or <i>rural property</i> .
<b>Non-residential property</b>	Means any <i>land</i> or buildings that are not included in <i>residential property</i> . Generally include: <ul style="list-style-type: none"> <li>• <i>non-residential buildings</i>;</li> <li>• <i>non-residential land</i>;</li> <li>• <i>rural property</i>; and</li> <li>• <i>non-building structures</i>.</li> </ul>
<b>Non-transaction deposits</b>	<p>Means all customers' <i>deposits</i>, other than <i>transaction deposits</i>.</p> <p><i>Non-transaction deposits</i> have limited access (e.g. only a limited number or value of withdrawals may be made from the account in a given period), incur penalties or fees (e.g. the loss of bonus interest, withdrawal fees), or have other restrictions on use of funds for payment or withdrawal.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• <i>fixed-term deposits</i>;</li> <li>• notice of withdrawal accounts, for which there is no fixed term but for which written notice is required at least the day before funds can be withdrawn or transferred out of the account;</li> <li>• savings <i>deposits</i> with restrictions or limitations on payments or withdrawals; and</li> <li>• money-market <i>deposit</i> accounts.</li> </ul> <p>It excludes: savings <i>deposits</i> linked to an account from which payments may be made to third parties (e.g. Automated Teller Machines, debit card or another electronic device) where funds may be transferred to the linked account almost instantaneously and subsequently withdrawn or transferred to a third party on demand.</p> <p>In practice, classify a <i>deposit</i> as <i>non-transaction deposits</i> where any of the following criteria are met:</p> <ul style="list-style-type: none"> <li>• more than 24 hours' notice is required to withdraw or transfer funds from the account;</li> <li>• the funds cannot be directly withdrawn, used for payment to a third party, or instantaneously transferred to a linked account from which either of these types of transactions can be conducted;</li> <li>• there is a restriction on the number of withdrawals or transfers than can be made (e.g. maximum of two withdrawals a month) or the rate of interest charged on the deposit differs based on whether a certain number of withdrawals have been made (e.g. bonus savings accounts); or</li> <li>• there is a restriction on or penalty charged for early withdrawal or transfer of funds (such as loss of interest earned on the remaining funds or a penalty fee other than a transaction fee).</li> </ul>

<i>Notes and coins</i>	Means holdings of physical currency. It includes: Australian and foreign currency notes and coins.

<i>Occupancy and equipment expenses incurred</i>	Refers to expenses incurred during the period from tangible assets. It includes: <ul style="list-style-type: none"> <li>• rental expenses on <i>operating leases</i>;</li> <li>• depreciation and repairs and maintenance of <i>property, plant and equipment</i>;</li> <li>• <i>utility expenses</i>; and</li> <li>• <i>property rates and taxes</i>.</li> </ul> It excludes: <ul style="list-style-type: none"> <li>• <i>wages and salaries</i> of own <i>employees</i>;</li> <li>• depreciation on <i>information technology equipment</i>;</li> <li>• rental expense for <i>information technology equipment</i>; and</li> <li>• <i>repairs and maintenance expenses</i> on software and <i>information technology equipment</i>.</li> </ul>
<i>Off-balance sheet securitised (assets)</i>	Means assets that have been removed from the institution's balance sheet because they were moved to an <i>SPV</i> for the purposes of a <i>securitisation</i> , and have been derecognised from the <i>domestic books</i> balance sheet under Australian Accounting Standards.
<i>Offices</i>	Means any <i>non-residential buildings</i> (or parts of such buildings) where the primary purpose is for clerical or professional duties.
<i>Offset accounts</i>	Means where a borrower has a <i>deposit</i> account and a <i>loan</i> (usually a <i>housing loan</i> ) with the same institution. Instead of receiving interest on the <i>deposit</i> account, the interest payment due on the <i>loan</i> is calculated on the net balance of the <i>loan</i> ( <i>credit outstanding</i> on the <i>loan</i> less any amount in the <i>deposit</i> account). <i>Offset accounts</i> typically refers to the value in the <i>deposit</i> account. For <i>offset accounts</i> , report the <i>interest rate</i> as the contractual rate payable on the linked <i>loan</i> account, divided by the proportion of the <i>offset account</i> balance that is offset against the <i>loan</i> balance. For instance, if the balance in



	<p>the <i>offset account</i> is fully offset against the <i>loan</i> balance, then the <i>interest rate</i> on the <i>offset account</i> would be the <i>interest rate</i> reported on the <i>loan</i> account. <b>Operating leases</b>	<p>Has the meaning in AASB <a href="#">16117</a>.</p> <p>In general, means a <i>lease</i> other than a <i>finance lease</i>. It does not transfer substantially all the risks and rewards incidental to ownership.</p>
<b>Original (maturity/term)</b>	Means the contractual <i>term</i> to maturity at issuance.
<b>Other deposit fees charged</b>	<p>Means all fees charged on <i>deposit</i> accounts (including <i>break fees</i> and <i>exception fees charged</i>) other than <i>account servicing fees charged</i> and <i>transaction fees charged</i>.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• <i>break fees charged</i>;</li> <li>• <i>exception fees charged</i>;</li> <li>• stopped payment fees;</li> <li>• duplicate statement and card replacement fees;</li> <li>• transaction verification fees;</li> <li>• bank cheque replacement and repurchase fees;</li> <li>• <i>deposit</i> book fees;</li> <li>• international cheque and money transfer fees; and</li> <li>• charges for travellers' cheques and foreign currency transactions associated with a <i>deposit</i> account, including the foreign currency fee on cash withdrawals (exclude the withdrawal fees charged. Report these as <i>transaction fees charged</i>).</li> </ul>
<b>Other fees charged</b>	<p>Means all banking-related <i>fees charged</i> other than <i>fees charged</i> associated with <i>deposits</i>, <i>loans</i>, <i>finance leases</i>, and <i>merchant fees charged</i>.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• export collection fees;</li> <li>• fees from international telegraphic transfers and foreign currency drafts from customers without a deposit or loan account;</li> <li>• guarantees;</li> <li>• fees for the transmission of deed or documents for inspection, delivery or execution;</li> <li>• safe custody and special clearances;</li> <li>• <i>short-term</i> money-market transaction fees;</li> <li>• coin and note handling services;</li> <li>• fees from the supply of certificates;</li> <li>• fees for legal, payroll and search services;</li> </ul>

	<ul style="list-style-type: none"> <li>• charges for travellers' cheques or foreign currency purchased with cash, or with <i>credit cards</i> issued by another institution;</li> <li>• fees for custodial and night safe services; and</li> <li>• fees for legal and service services.</li> </ul> <p>It excludes:</p> <ul style="list-style-type: none"> <li>• government taxes;</li> <li>• fees associated with insurance operations or funds management;</li> <li>• package fees. Include these with the product (<i>deposit</i> account or <i>loan</i>) that they most relate to; and</li> <li>• charges imposed by the group treasury, such as costs charged to the business unit by treasury from termination swaps (i.e. do not report <u>net</u> fee income).</li> </ul>
<b>Other intangible assets</b>	Refers to items such as trademarks, company brand, customer databases, licenses, patents and <i>goodwill</i> .
<b>Other loan and finance lease fees charged</b>	Means all fees related to <i>loans</i> and <i>finance</i> other than <i>account servicing fees charged</i> and <i>transaction fees charged</i> . It includes: <ul style="list-style-type: none"> <li>• <i>break fees charged</i>;</li> <li>• <i>exception fees charged</i>;</li> <li>• prepayment fees and repayment holiday fees;</li> <li>• early repayment fees;</li> <li>• switching fees; and</li> <li>• reference fees.</li> </ul>
<b>Other margin loans</b>	Means any <i>margin loans</i> that are not <i>standard margin loans</i> or <i>protected margin loans</i> .
<b>Other non-residential buildings</b>	Means any <i>non-residential buildings</i> (or parts of such buildings) that are not <i>shops</i> , <i>offices</i> or <i>industrial buildings</i> . It includes: hotels and buildings for educational, religious, health, entertainment and recreational purposes.
<b>Other non-transaction deposits</b>	Means all customers' <i>non-transaction deposits</i> that are not <i>fixed-term deposits</i> .
<b>Other outsourced information technology services</b>	Represents information technology related services purchased from external services providers. It includes: <ul style="list-style-type: none"> <li>• outsourced <i>information technology equipment</i> installation costs;</li> <li>• outsourced data processing services. Data processing services relate to the transformation of data into a suitable output other than data entry and manipulation services;</li> <li>• outsourced web hosting services;</li> <li>• outsourced electronic information storage services; and</li> </ul>

	<ul style="list-style-type: none"> <li>outsourced computer system design relating to computer hardware, computer programming, internet and web design and system analysis.</li> </ul> <p>It excludes: computer software installation costs paid to external service providers.</p>
<b>Other transport vehicles and equipment</b>	<p>Refers to equipment and vehicles for moving people and objects. This may include items such as ships, railway and tramway locomotives, rolling stock, aircraft and attachments such as trailers, semi-trailers.</p> <p>It excludes: vehicles that are primarily to be used on the road such as cars, trucks, motor cycles and utes. Report these as <b>road vehicles</b>.</p>
<b>Overseas equities</b>	<p>Means shares that are quoted on stock exchanges other than an Australian stock exchange.</p>
<b>Owner-occupied (housing loan)</b>	<p>Means a <b>loan</b> to a <b>household</b> for the purpose of <b>housing</b>, where the funds are used for a <b>residential property</b> that is occupied or to be occupied by the borrower(s) as their <b>principal place of residence</b>.</p> <p>Where the <b>loan</b> is for a <b>residential property</b> that is different to the <b>residential property</b> against which the <b>loan</b> is <b>secured</b>, this definition refers to the occupation status of the <b>residential property</b> for which the <b>loan</b> has been obtained (not the occupation status of the <b>residential property</b> used as security).</p> <p>It includes:</p> <ul style="list-style-type: none"> <li><b> dwellings and residential land</b> that are vacant while under <b>construction</b>, but that the borrower intends to occupy as a <b>principal place of residence</b>;</li> <li>part-time residences that are the borrower's or borrowers' <b>principal place of residence</b>.</li> </ul> <p>It excludes:</p> <ul style="list-style-type: none"> <li>part-time residences that are not the borrower's or borrowers' <b>principal place of residence</b>. <b>Partially secured</b>	<p>Means finance that is <b>secured</b> and has an <b>LVR</b> of greater than 100%.</p>
<b>Past due</b>	<p>A facility subject to a regular repayment schedule is regarded as X days <b>past due</b> when:</p> <ol style="list-style-type: none"> <li>at least X calendar days have elapsed since the due date of a contractual payment that has not been met in full; and</li> <li>the total amount outside contractual arrangements is equivalent to at least X days' worth of contractual payments.</li> </ol>

	<p>An item ceases to be classified as <i>past due</i> when arrears have been reduced so that the exposure is no longer X days <i>past due</i>.</p> <p>In the case of facilities that do not have a pre-set repayment schedule, <i>past due</i> refers to the period where facilities have remained continuously outside approved arrangements but are well <i>secured</i>.</p>

<i>Personal Investment</i>	<p>Refers to <i>personal loans</i> to purchase assets that are expected to maintain or increase in value other than housing.</p> <p>It excludes:</p> <ul style="list-style-type: none"> <li>• <i>housing</i> for the purposes of investment; and</li> <li>• <i>margin loans</i>.</li> </ul>
<i>Personnel expenses</i>	Refers to remuneration related expenses incurred during the period.
<i>Per-transaction merchant fees charged</i>	Means all transaction-based <i>merchant fees charged</i> for acquiring card transactions, whether collected on an <i>ad valorem</i> or flat basis. Include transactions involving cards issued to <i>households</i> or businesses, either in Australia or overseas. Report income from merchants net of rebates and concessions.
<i>Plant and equipment</i>	<p>Means any <i>property, plant and equipment</i> asset that is not <i>property</i>.</p> <p>Such assets are typically vital to business operations but cannot be easily liquidated.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• <i>road vehicles</i>;</li> <li>• <i>other transport vehicles and equipment</i>;</li> <li>• construction and earthmoving equipment;</li> <li>• agriculture machinery; and</li> <li>• electronic data processing and office equipment.</li> </ul>
<i>Postage expenses</i>	<p>Refers to expenses related to postage, mailing and courier expenses. <b>Preference shares</b>	Means a type of <b>equity security</b> that has a priority over dividend payments and to the assets of the company.
<b>Principal amount</b>	Means the cash consideration (post- <b>haircut</b> ) on the initial leg of a <b>repo</b> or securities <b>loan</b> contract.
<b>Principal place of residence</b>	Means the <b>residential property</b> at which an individual resides for the majority of the year.
<b>Property</b>	Means <b>land</b> , a building – or part thereof – or both. A building can take the form of a <b>dwelling</b> (or a group of <b>dwellings</b> ) or a <b>non-residential building</b> .
<b>Property, plant and equipment</b>	Has the meaning as in <i>AASB 116 Property, Plant and Equipment</i> (AASB 116).
<b>Property rates and taxes</b>	<p>Include amounts paid for land tax, municipal rates and metropolitan improvement rates, where:</p> <ul style="list-style-type: none"> <li>• land tax consists of taxes on the ownership of land based on the assess value of the land;</li> <li>• municipal rates consist of levies imposed by local government authorities on the assessed value of property for the purpose of financing municipal services. Exclude amounts collected with municipal rates but identified as charges for direct supply of goods and services such as water, sewerage rates and garbage charges; and</li> <li>• metropolitan improvement rates consist of levies on property owners intended specifically for financing the planning and development of land within the metropolitan region. It includes levies used for the acquisition of land for the development of metropolitan parks; support of regional studies; financing open space improvements.</li> </ul>
<b>Protected margin loans</b>	<p>Means <b>margin loans</b> that have a maximum allowable <b>LVR</b> of 100 per cent and the lender guarantees that the value of the borrower's underlying <b>security</b> will not be less than the value of <b>credit outstanding</b> at the end of the predetermined investment horizon.</p> <p>Borrowers with <b>protected margin loans</b> do not receive <b>margin calls</b>, but are charged a significantly higher <b>interest rate</b> than for <b>standard margin loans</b>. <b>Protected margin loans</b> in effect combine a <b>standard margin loan</b> with a put option on the assets purchased.</p>
<b>Provisions for dividends</b>	Means the allowance that the <b>ADI</b> or <b>RFC</b> has made in terms of the obligation for declared dividends.

The rebate fee is predetermined in a securities lending agreement between the borrower and lender (or the agent on the lender's behalf) and should be expressed as an annualised percentage of the market value of the securities borrowed.</a></u>

<b><i>Recoveries</i></b>	Refers to the value of reversals of impairment losses on financial assets as determined in accordance with Australian Accounting Standards.
<b><i>Redraw facility</i></b>	<p>Means a facility that enables a borrower to access (subject to conditions) the accumulated <b><i>excess repayments</i></b> they have made towards their <b><i>loan</i></b>.</p> <p>The balance of funds in a <b><i>redraw facility</i></b> is typically offset against the balance of the <b><i>loan</i></b> amount when calculating interest payable.</p> <p>While <b><i>redraw facilities</i></b> are a type of <b><i>revolving credit</i></b> facility, where they are attached to a <b><i>fixed-term loan</i></b> report them as <b><i>fixed-term loans</i></b> as there is typically not a separate contract.</p>
<b><i>Reinvestment asset</i></b>	Means the <b><i>collateral</i></b> pledged by the borrower of a security in a <b><i>securities lending</i></b> contract.
<b><i>Reinvestment rate</i></b>	Means the rate of return earned on the cash proceeds generated by stock lending activity.
<b><i>Rental, repairs and maintenance expenses</i></b>	Refers to the value of rental expense incurred for using rented equipment and the value of <b><i>repair and maintenance expenses</i></b> .
<b><i>Repairs and maintenance expenses</i></b>	<p>Refers to the value of ordinary maintenance and repairs that are obliged to be undertaken periodically in order to be able to utilise assets over their expected services lives. They are costs that cannot be avoided if the assets are to continue to be used.</p> <p>Maintenance and repairs do not change the asset or its performance, but simply maintain it in good working order or restore it to its previous condition in the event of a breakdown.</p> <p>It excludes: <b><i>wages and salaries</i></b> of own <b><i>employees</i></b>.</p>
<b><i>Repurchase agreement (repo)</i></b>	Means a contractual arrangement involving the provision of securities or other financial assets (collateral) in exchange for cash with a commitment to repurchase the same or similar collateral at a fixed price either on a specified future date or on demand.
<b><i>Repo rate</i></b>	Means the percentage difference between the purchase and repurchase price of a security expressed as an annual rate.
<b><i>Residential land</i></b>	<p>Means any vacant <b><i>land</i></b> that does not have a <b><i>dwelling</i></b> attached but where the <b><i>construction</i></b> of a <b><i>dwelling</i></b> is allowed under zoning regulations.</p> <p>It excludes: land where the primary purpose of the land will be for <b><i>business</i></b> purposes. Report this under the appropriate business category.</p>
<b><i>Residential property</i></b>	Means <b><i>residential land</i></b> and buildings – or parts thereof – that take the form of <b><i>dwellings</i></b> or a group of <b><i>dwellings</i></b> .
<b><i>Residual maturity/term</i></b>	Means the remaining <b><i>term</i></b> to contractual maturity.
<b><i>Retirement savings</i></b>	Means low risk/low return capital guaranteed products that are subject to the same restrictions as other superannuation products. Only an <b><i>ADI</i></b> , <b><i>life insurance corporation</i></b> or a prescribed <b><i>financial institution</i></b> can be approved

<b>accounts (RSAs)</b>	by APRA to act as an RSA under the <i>Retirement Savings Act 1997</i> . RSAs are specifically approved non-trustee institutions.
<b>Reverse mortgage</b>	Means a <i>loan secured</i> by <i>residential property</i> in which repayments are generally deferred and capitalised, with full repayment due when the borrower is deceased, sells the property or moves out of the property. Generally, the <i>loan</i> can be taken as a lump sum, a regular income stream, a line of credit or a combination of these options.  For reporting purposes, treat these <i>loans</i> like a <i>revolving credit</i> facility. Include any accrued interest in the <i>credit limit</i> and the <i>credit outstanding</i> .
<b>Reverse repo</b>	The buyer of the asset in a <i>repo</i> is referred to as conducting a <i>reverse repo</i> .
<b>Revolving credit</b>	Means lending facilities that the borrower may repeatedly <i>draw down</i> in part or in full up to an authorised <i>credit limit</i> and repay, any credit drawn, in part or in full, on multiple occasions without the facility being cancelled. Repayments (other than of charges and interest) reduce the borrowings, thereby increasing the amount of unused credit available. Include facilities with a fixed term that meet the above criteria.  It includes: <ul style="list-style-type: none"> <li>• arranged overdrafts. These are generally an agreed arrangement between a lender and a borrower to extend credit when the balance in an attached transaction account falls below zero;</li> <li>• unarranged overdrafts. These refer to the situation when a transaction account holder withdraws an amount greater than the balance of the account leaving a negative balance. The lender usually charges an overdrawn account fee as well as interest on the negative balance, and usually requires the account holder to restore the account's positive balance;</li> <li>• <i>secured</i> and <i>unsecured revolving credit</i> facilities; and</li> <li>• <i>reverse mortgages</i>.</li> </ul> It excludes: <ul style="list-style-type: none"> <li>• <i>redraw facilities</i> attached to <i>fixed-term loans</i>; and</li> <li>• <i>bill</i> facilities.</li> </ul>
<b>Road vehicles</b>	Refers to vehicles that are primarily to be used on the road such as cars, trucks, motor cycles and utes.  It excludes: attachments such as trailers, semi-trailers. Report these as <i>other transport vehicles and equipment</i> .
<b>Royalties income/expense</b>	Refers to payments made by one business or individual for the use of rights owned by another business or individual. Do not deduct withholding tax.  It includes: <ul style="list-style-type: none"> <li>• payments under licensing arrangements; and</li> <li>• payments of royalties from intellectual property (e.g. patents, copyrights, etc.).</li> </ul> It excludes: <ul style="list-style-type: none"> <li>• expensed computer software licence fees; and</li> </ul>



	<ul style="list-style-type: none"> <li>capitalised computer software licence fees.</li> </ul>
<b>Rural property</b>	Means any <b>land</b> where the primary purpose is for agricultural or pastoral use.

## S

<b>Scheduled repayments</b>	<p>Means the contracted, agreed or minimum repayment amount. It is the total (interest and any other fees or charges plus principal as appropriate) value of payments due during the relevant period, in accordance with the <b>loan</b> conditions.</p> <p><b>Scheduled repayments</b> may exceed the minimum required repayment possible under the <b>loan</b> conditions.</p>
<b>Secured (finance)</b>	Means finance for which the lender has recourse to an asset pledged by the borrower or a third party (the collateral) in the event of default by the borrower.
<b>Securities borrowing</b>	The borrower of the security in a <b>securities lending</b> agreement can be said to be undertaking <b>securities borrowing</b> activity.
<b>Securities lending</b>	Means a lending arrangement under which a holder of a security agrees to provide the security to a borrower for a specified period of time. <b>Loans</b> are typically executed under standardised agreements, which give the borrower full title for the term of the <b>loan</b> . The lender typically charges a fee for the <b>loan</b> and requires the borrower to post collateral.
<b>Securitisation</b>	<p>Involves the creation of a financing structure where the cash flow from a pool is used to make payments on obligations to at least two tranches or classes of creditors (typically holders of <b>debt securities</b>), with each tranche or class entitled to receive payments from the pool before or after another class of creditors, thereby reflecting different levels of credit risk. Payments to the investors depend upon the performance of the underlying exposures, as opposed to being derived from an obligation of the entity originating those exposures.</p> <p>The tranching structures that characterise <b>securitisation</b> differ from ordinary senior/subordinated debt in that junior <b>securitisation</b> tranches can absorb losses without interrupting contractual payments to more senior tranches, whereas subordination in a senior/subordinated debt structure is a matter of priority of rights to the proceeds of liquidation.</p> <p>The securities are backed by a pool of specific assets, often <b>housing loans</b>, and the securities can be <b>short-term</b> or <b>long-term</b>.</p> <p><b>Securitisation</b> exposures have the meaning in <i>Prudential Standard APS 120 Securitisation</i> (APS 120).</p>
<b>Security</b>	Means an asset (or assets) pledged by the borrower or a third party against a <b>loan</b> . In the event of default by the borrower, the lender has recourse to this asset.
<b>Self-securitised</b>	Relates to a <b>securitisation</b> that is solely for the purpose of using the securities created as collateral in order to obtain funding via a repurchase agreement with the <b>RBA</b> .

	<i>Self-securitisation</i> is also known as an internal securitisation.
<i>Semi-government securities</i>	Means the debt obligations of a <i>central borrowing authority</i> of a state or territory of the Commonwealth of Australia.  It includes: <i>fixed-interest rate</i> bonds, linked bonds and Treasury notes issued by a state or territory of the Commonwealth of Australia.
<i>Senior unsecured debt</i>	Means any <i>unsecured debt security</i> that must be repaid ahead of all other <i>unsecured</i> and <i>subordinated debt</i> security holders other than those outlined in <a href="#">paragraphs section 13A(3)(a)-(e)</a> of the <a href="#">Banking Act 1959</a> in the event that the <i>ADI</i> is unable to meet its obligations or is about to suspend payment.
<i>Set-off accounts</i>	Means linked <i>deposit</i> and <i>loan</i> accounts that pay a different <i>interest rate</i> depending on whether the linked accounts are in a net <i>loan</i> or net <i>deposit</i> position.  They are similar to <i>offset accounts</i> but differ in that, if the linked accounts are in a net <i>deposit</i> position, the customer will be due interest.
<i>Share-based payment expense</i>	Refers to employee share-based payments and stock options, expensed to the <i>ADI</i> or <i>RFC</i> for remunerating employees, incurred during the period.
<i>Shops</i>	Means any <i>non-residential buildings</i> (or parts of such buildings) where the primary purpose is to sell goods or services.
<a href="#"><u>Short-sold position</u></a>	<a href="#"><u>Means the value of positions from the sale of a borrowed security in anticipation of making a profit by repurchasing it after its price has fallen, prior to maturity.</u></a>
<i>Short-term</i>	Means an <i>original maturity</i> of less than or equal to 12 months.
<i>Small (business size)</i>	A business is classified as <i>small</i> if the <i>ADI</i> or <i>RFC</i> has an exposure to the business that is less than \$1 million and the business has <i>turnover</i> of less than \$50 million.  Include exposures classified by <i>ADIs</i> using the internal ratings-based approach to credit risk as ‘SME Retail’ in this category.
<i>Standard margin loans</i>	Means <i>margin loans</i> that typically have a maximum allowable <i>LVR</i> of 40 to 80 per cent, depending on the type of stock or managed fund that is provided as <i>security</i> for the <i>margin loan</i> .  These <i>loans</i> are subject to <i>margin calls</i> if a decline in the value of the underlying <i>security</i> raises the <i>LVR</i> above the pre-specified maximum.
<i>Stationery expense</i>	Refers to costs incurred for office supplies and printing carried out by or for the business.  It includes: <ul style="list-style-type: none"> <li>• all office stationery; and</li> <li>• production of financial reports, etc.</li> </ul>
<i>Subordinated</i>	Represents any asset or liability that will, in entirety or in part, not be repaid until other specified creditors are repaid.

<b><i>Subordinated debt</i></b>	Means any <b><i>debt security</i></b> that is repaid after those outlined in <a href="#">paragraphssection</a> 13A(3)(a)-(e) of the <a href="#">Banking Act 1959</a> and after senior debtholders in the event that the <b><i>ADI</i></b> is unable to meet its obligations or is about to suspend payment.
<b><i>Supra-national and foreign agency-issued debt securities</i></b>	Means debt obligations of intergovernmental, governmental or quasi-governmental organisations.
<b><i>Syndicated loans</i></b>	Means an extension of credit where the funds are jointly provided by two or more lenders.  <b><i>Syndicated loans</i></b> possess a single <b><i>loan</i></b> agreement, but each participant to a <b><i>syndicated loan</i></b> maintains a separate claim on, and bears the credit risk for, the portion of the <b><i>loan</i></b> that it has provided.

## T

<b><i>Telecommunications services and internet services</i></b>	Refers to payments (of a non-capital nature) for telecommunication and internet services that engage wire, cable or radio transmission.  It includes: <ul style="list-style-type: none"> <li>• telephone charges;</li> <li>• facsimile charges;</li> <li>• internet charges; and</li> <li>• cost of leased lines for computers and internet services.</li> </ul> It excludes: installation costs.
<b><i>Tenor</i></b>	See <b><i>original (maturity/term)</i></b> .
<b><i>Term</i></b>	Means length of time until maturity.  For <b><i>original maturity</i></b> , this refers to the length of time from origination until maturity.  For <b><i>residual maturity</i></b> , this refers to the length of time from the reporting period until maturity.
<b><i>Tier 2 capital instruments</i></b>	Refers to instruments that are compliant with the definition in <i>Prudential Standard APS 111 Capital Adequacy: Measurement of Capital</i> (APS 111). Excludes instruments that do not fully meet the criteria in Attachment H (whether or not these are eligible for transitional treatment under Attachment L of APS 111).
<b><i>Trade credit</i></b>	Refers to goods or services purchased for which the corresponding payment is deferred past the date on which the good or service is received.
<b><i>Trade date</i></b>	Means the date on which the <b><i>repo</i></b> or <b><i>reverse repo</i></b> was contracted.
<b><i>Trade finance</i></b>	Means the provision of credit for the purpose of facilitating trade transactions. The finance relates to and is directly underpinned by the movement of goods or the provision of services such as documentary trade letters of credit, documentary and clean collection, import bills, export bills and shipping guarantees.

	<p>A typical relationship is where the intermediary provides upfront payment to an exporter, and allows the importer to repay this credit once delivery is confirmed.</p>
<b>Trading book</b>	<p>Means positions in financial instruments that are held either with trading intent or to hedge other elements of the trading book. Positions held with trading intent are those which:</p> <ul style="list-style-type: none"> <li>• are held for short-term resale; or</li> <li>• are taken on with the intention of benefiting in the short-term from actual and/or expected differences between their buying and selling prices, or from other price or interest rate variations; or</li> <li>• arise from broking and market-making.</li> </ul> <p>For an <b>ADI</b> this will include positions in financial instruments that meet the requirements of <i>Prudential Standard APS 116 Capital Adequacy: Market Risk</i> (APS 116).</p>
<b>Trading securities</b>	<p><u>Has the same meaning as in AASB 9.</u> These assets must be acquired <del>for</del> principally for the purpose of short-term profit-taking. <u>Trading securities are defined in accordance with AASB 9.</u></p>
<b>Transaction deposits</b>	<p>Means all <b>deposits</b> that are directly accessible and exchangeable for <b>notes and coins</b> on demand at par and without penalty or restriction.</p> <p>The funds are directly accessible if they can be withdrawn or used to make payments to a third party by draft, giro order, direct debit/credit, cheque or another direct payment facility on demand.</p> <p>Examples of penalties or restrictions include limits on the value or volume of withdrawals in a given period and penalty fees or loss of bonus interest for withdrawals or other access to make payments.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• accounts from which payments may be made to third parties (e.g. Automated Teller Machines, cheque, debit card or another electronic device); and</li> <li>• savings <b>deposits</b> linked to an account from which payments may be made to third parties (e.g. Automated Teller Machines, debit card or another electronic device) where funds may be transferred to the linked account almost instantaneously and subsequently withdrawn or transferred to a third party on demand <u>without penalty.-</u></li> </ul>
<b>Transaction fees charged</b>	<p>Means fees charged that relate to transactions made, generally charged to the party initiating the transaction.</p> <p>For <b>deposits</b> it includes <b>fees charged</b> on:</p> <ul style="list-style-type: none"> <li>• branch-assisted withdrawals and <b>deposits</b>;</li> <li>• cheque payments and cashing, including bank cheques;</li> <li>• EFTPOS, BPAY, direct debit and/or periodic payments; and</li> <li>• ATM, internet or telephone banking transactions, including withdrawals, <b>deposits</b> and balance enquiries.</li> </ul>

	For <i>loans</i> and <i>finance leases</i> it includes <i>fees charged</i> on: drawdowns and redraws on <i>loans</i> and <i>finance leases</i> .
<b><i>Travel, accommodation and entertainment expenses</i></b>	<p>Travel expenses are costs incurred for transportation services relating to business activities that occur away from the normal place of business. These costs are only to be included if they are incurred in connection with business activities.</p> <p>Accommodation expenses are those costs incurred in providing accommodation to staff when business activities occur away from the normal place of business.</p> <p>Entertainment expenses are the costs incurred by a business for the provision of entertainment activities.</p>
<b><i>Tri-party agent (tri-party)</i></b>	Means custodian <i>banks</i> to which <i>collateral</i> selection, payment and settlement, custody and management during a <i>repurchase agreement</i> is outsourced.
<b><i>Turnover</i></b>	Means the value of total sales made by a business during the most recent year. Calculate this using the values that the borrower reports to the Australian Taxation Office through Business Activity Statements.

## U

<b><i>Unallocated gold</i></b>	Means an account that does not give the holder the title to physical gold but provides a claim against the account operator to deliver gold.
<b><i>Unearned interest</i></b>	Refers to interest received in advance but not yet earned. For example, on a <i>fixed-interest rate loan</i> portfolio.
<b><i>Unique transaction identification number</i></b>	<del>Means a number</del> <u>Means any combination of letters and/or numbers</u> assigned by the <i>ADI</i> or <i>RFC</i> that uniquely identifies the <i>repo</i> , <i>reverse repo</i> , <i>securities lending</i> transaction or <i>securities borrowing</i> transaction.
<b><i>Unsecured (finance)</i></b>	Means finance that is not <i>secured</i> .
<b><i>Utility expense</i></b>	<p>Refers to expenses incurred related to utilities.</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>• water rates and any excess water charges; and</li> <li>• electricity and gas charges.</li> </ul>

## V

<b><i>Valuables</i></b>	Means assets acquired as stores of value that do not deteriorate in value over time and are not used in a production process.
<b><i>Value of funds</i></b>	<p>Means the institution's internal funds transfer pricing rate for a liability. The price is established by the institution's treasury area and 'credited' to the relevant business area.</p> <p>This includes:</p>

	<ul style="list-style-type: none"> <li>liquidity, term, cash, interest rate, prepayment, optionality, and basis risks; and</li> <li>strategic pricing, regulatory cost (excluding capital costs), cross-subsidisation and liquidity mismatch.</li> </ul> <p>Where there are multiple <i>values of funds</i> within a line item, report the weighted average of these amounts.</p>
<b>Variable interest rate</b>	Means <u>an interest rate</u> that <u>fluctuates</u> over the <i>term</i> , or life, of the agreement. Fluctuations in <i>interest rates</i> generally occur at the discretion of the lender and/or in response to movements in some other interest rate or other variable specified in the contract. These fluctuations in <i>interest rates</i> may result in changes to required payments or length of the agreement.

## W

<b>Wages and salaries</b>	<p>Refers to gross earnings of <i>employees</i> before taxation and other deductions.</p> <p>Report <i>wages and salaries</i> as recorded in the <i>ADI's</i> and <i>RFC's</i> financial or management accounts, including provisions for employee entitlements (i.e. on an accruals basis).</p> <p>It includes:</p> <ul style="list-style-type: none"> <li>severances, terminations and redundancies;</li> <li>salaries and fees of directors and executives;</li> <li>retainers and commissions of persons who received a retainer; and</li> <li>annual and other types of leave.</li> </ul> <p>It excludes:</p> <ul style="list-style-type: none"> <li>capitalised <i>wages and salaries</i>;</li> <li>salary sacrifice for superannuation;</li> <li>payments to other businesses/organisations for staff (e.g. employment agencies);</li> <li>payments to self-employed persons such as consultants and persons paid solely by commission without a retainer.</li> <li>payments to contractors for services;</li> <li><i>fringe benefit tax</i> and <i>payroll tax</i>; and</li> <li>reimbursement of expenses (e.g. travel, entertainment, meals and other expenses).</li> </ul>
<b>Weighted average</b>	<p>Means the weighted sum of individual items, where the weights used are the corresponding balances expressed as a share of the total balance.</p> <p>For a <i>weighted average interest rate</i>, the items summed are the <i>interest rates</i>.</p> <p>For a <i>weighted average term</i>, the items summed are the <i>original</i> or <i>residual terms</i>, as directed.</p>
<b>Wholesale finance</b>	<p>Means finance for the purchase of goods that will then be on-sold.</p> <p>It excludes: finance to assist with the everyday operations of the business. Report this as <i>working capital</i>.</p>

<b><i>‘Work in progress’ information technology equipment</i></b>	Refers to <b><i>information technology equipment</i></b> classified as <b><i>property, plant and equipment</i></b> (including software applications that are an integral part of the hardware) that is under development and not ready for use in the production process as at the reporting date.
<b><i>Workers’ compensation premiums/costs</i></b>	Refers to a compulsory insurance cover to be taken out by all employers, except for self-insured workers, according to legislative schemes to cover employees suffering injury or disease in the course of or arising out of employment.
<b><i>Working capital</i></b>	Means a <b><i>loan</i></b> used to finance everyday operations of the business, such as accounts payable and wages.  It excludes: finance to purchase goods that will then be on-sold. Report this as <b><i>wholesale finance</i></b> .
<b><i>Write-backs</i></b>	Refers to the impairment charged to profit and loss in respect of impairment losses on financial assets not measured at fair value through profit or loss, as determined in accordance with Australian Accounting Standards.
