REFRESHING APRA'S STATISTICS PUBLICATIONS FOR AUTHORISED DEPOSIT-TAKING INSTITUTIONS

APRA is refreshing its statistical publications for authorised deposit-taking institutions (ADIs), as a result of changes that modernised the underlying data collection. ADI financial statement data is now being collected using the new Economic and Financial Statistics (EFS) collection, under section 13 of the *Financial Sector (Collection of Data) Act 2001* (FSCODA). APRA collects this data on behalf of the Australian Bureau of Statistics and Reserve Bank of Australia. The EFS collection is being implemented using a phased approach with differing impacts for APRA's monthly and quarterly ADI statistics publications.¹

APRA's monthly ADI statistical publication

APRA is releasing a new template for the *Monthly ADI Statistics* (MADIS) publication, along with new explanatory notes and a glossary for information. MADIS is replacing APRA's *Monthly Banking Statistics* (MBS) from July 2019.

The new publication MADIS will contain information on assets and liabilities for selected individual ADIs, including details on loans and finance leases and deposits from different sectors of the economy. MADIS will contain data for domestic and foreign banks and, for the first time, building societies, larger credit unions and other ADIs, in line with APRA's objective to increase the transparency of data it collects for the ADI sector.

Phase 1 of the EFS data collection introduces new reporting forms to replace the existing *Reporting Form ARF 320.0 Statement of Financial Position (Domestic Books)* (ARF 320.0). These new forms will provide the source data for MADIS. In most cases, these data items will be conceptually similar to those that were published in MBS. However, there will be some changes and the new publication will benefit from the improved definitions in the EFS collection.

APRA initially consulted on the new publication in November 2018.² Following a review of the first few months of parallel run data, APRA has made some minor changes to the MADIS template. These changes, detailed in Attachment 1, involve:

- re-naming Cash and liquid assets as Cash and deposits with financial institutions;
- re-naming Outstanding principal balance of securitised assets as Total securitised assets on balance sheet.

- removing the Value of housing loans securitised held off-balance sheet from the publication; and
- splitting Total borrowings into Total short-term borrowings and Total long-term borrowings.

The first release of MADIS at the end of August 2019 will contain data collected for the period ending 31 July 2019 and four months of the parallel run data, from the period ending 31 March 2019, when the new EFS data collection started.³

MBS will cease after 30 June 2019, although historical data will remain available.

APRA's quarterly ADI statistical publications

APRA's Quarterly Authorised Deposit-taking Institution Property Exposures and Quarterly Authorised Deposit-taking Institution Property Exposure Statistics publications will also be affected by the introduction of new data during Phase 1 of the EFS data collection. However, the impact is expected to be limited.

Quarterly Authorised Deposit-taking Institution Property Exposure Statistics will also be impacted by Phase 2 of the EFS reporting form changes, in particular the cessation of Reporting Form ARF 320.8 Housing Loan Reconciliation (ARF 320.8) in September 2019. There will be further communications about this publication in the near future.
