1 Meeting objectives and priorities (Daniel Hunt)

Daniel Hunt welcomed members of the group and confirmed the meeting objectives.

3 Project update

<u>Progress update</u>: APRA provided an update on DCS outlining that they were well-progressed in the procurement activity with the preferred tenderer having been notified and APRA currently preparing for contract negotiations.

<u>Implementation plan</u>: APRA outlined that the Implementation Plan had two planned releases with a draft being made available in April and a final release in June/July 2019; this approach had been agreed with the preferred vendor.

TWG members provided insightful feedback on topics such as testing timelines, technical specs and potential readiness approaches.



4 External test environment and test approach

APRA provided an overview of APRA's proposed external test environment and planned test approach for entities. APRA planned for the external test environment to be secure and a close replica of the production environment. APRA proposed for external testing to occur in two to three large drops and highly recommended external entities make full use of the external test environment to confirm readiness.

TWG members provided their input to the topic by highlighting that entities could potentially assist with load and performance testing in addition to functional testing. Members also noted that it would be advisable to have the same authentication solution across the external test and production environments. Members encouraged APRA to consider how testing will be managed for service providers / administrators (e.g. HAMBS).
